In conjunction with the ongoing environmental cleanup efforts at the Former BP Paulsboro Terminal (Site), the New Jersey Department of Environmental Protection (NJDEP) established what is known as a groundwater Classification Exception Area (CEA). A CEA identifies areas where chemical concentrations in groundwater are above the NJDEP's groundwater quality standards. Every two years, the NJDEP requires that the CEA be evaluated to ensure that conditions have not changed, and that any groundwater control measures put in place continue to be protective of human health and the environment.

A comprehensive environmental investigation, findings of which were documented in a report approved by the NJDEP in 2007 and presented to the community at a public meeting in 2008, demonstrated that there were no impacts from historic terminal operations to the community's drinking water, nor were there any off-site vapor intrusion risks to properties neighboring the Site here in Paulsboro. The results of continued monitoring since that time indicate there have been no adverse changes in off-site conditions, and groundwater control and cleanup measures put in place by BP continue to be protective of human health and the environment.

The CEA for this Site was established in February 2009 in conjunction with a long-term groundwater cleanup plan. A copy of the CEA fact sheet with more information is posted on the web site for the BP Paulsboro Project: www.bpaulsboronj.com. Enclosed with this letter is a copy of the CEA biennial certification form, which is required by NJDEP to be distributed to all properties located within the established CEA extent.
